Re: Response to unlawful issue of threat to place a lien of properties at 296 Shaker Rd. Belmont
Request for clarification

Dear Jennifer Cashman,

As you may recall:

- On December 18, 2023 we informed you by letter of our discovery that supporting the "School Tax" and the "Education Tax" conflicts with our deeply held spiritual and religious beliefs. At that time we began to amend our "TAX CALCULATION" to omit the inclusion of the "School Tax" amount, and the "Education Tax" amount.
- On December 20, 2023 you, Jennifer Cashman, acting as Tax Collector and Town Clerk for the TOWN OF BELMONT, responded with a short letter claiming that “there is no religious exemption for property taxes”, which you claimed to have confirmed with your lawyer.
- On May 13, 2024 we hand delivered a letter: “**Demand Proof of Claim of Property Tax Requirement**”, accompanied by a sworn and notarized **Affidavit** detailing the facts that support our claim that paying for the “Education Tax” and “School Tax” is a violation of our deeply held spiritual and religious beliefs.
- On May 21, 2024 we received a letter from you with a brief and insufficient response stating that our May 13th information had been forwarded to the legal department and their response remained the same. “There is no property tax exemption for religious beliefs”.
- On July 1, 2024 I wrote a letter, for which hand delivery was refused, which was delivered on August 26, 2024 via Certified US Mail, to respond to your May 21st insufficient reply, by reiterating our demand, notifying you of the response that is required, and offering that failure to respond with a sufficient reply conveys your agreement to the amended contract.
- On December 12, 2024, having never received a sufficient reply from you or anyone in the Town of Belmont or State of New Hampshire in response to our May 13th, 2024 letter and affidavit, I wrote a letter detailing the communication listed above, and **offering you notice** that “**an un rebutted Affidavit stands as Truth**”, and that “**Your failure to offer a sufficient reply is your admission to the statements made in our May 13, 2024 Affidavit and has conveyed your agreement to the terms of the amended contract titled “PROPERTY TAX BILL” to exclude “School Tax” and “Education Tax”.**”

Legal Maxim: “A claim not contested, stands true.”

Legal Maxim: “A claim bought in law that is not contested or rebutted, then stands true. Hence silence to a controversy is considered consent to any judgment.”

Legal Maxim: “He who does not deny, admits.” “Silence can only be equated with fraud where there is a legal or moral duty to speak, or where an inquiry left unanswered would be intentionally misleading”

Notice:

Absent a rebuttal, and absent proof of the claim to our property as offered in the “REAL ESTATE TAX BILL”, Jennifer Cashman, acting as Tax Collector and Town Clerk for the TOWN OF BELMONT in the STATE OF NEW HAMPSHIRE continues to acknowledge, understand and agree that the Contracts titled “REAL ESTATE TAX BILL” for our two properties known as _____ *Address removed online for privacy. _____ have been amended to exclude “Education Tax” and “School Tax” ad infinitum. Furthermore, any penalties in the form of “Tax Liens” and accompanying costs, “Tax Deeds”, or any other claimed penalties such as “TAX DELINQUENCIES” and “UNREDEEMED TAX LIENS” are VOID nunc pro tunc.

Quoted from our May 13, 2024 letter and Affidavit:

We demand proof of the following:

1. That we are contractually obligated or required under penalty to pay property taxes to the TOWN OF BELMONT by citing specific law(s) or statute(s).

[*please note: I have not found a statute requiring that we pay property tax. Section 72:6 was repealed in 1995.]

2. That the STATE OF NEW HAMPSHIRE, TOWN OF BELMONT, Jennifer Cashman acting as Town Clerk - Tax Collector, or any man or woman, principality, corporation, municipality, state, or government in Earth has the right to violate our unalienable right to religious freedom by imposing a tax that violates our sincerely-held beliefs.
3. That the public schools in New Hampshire, including Belmont public schools, are exclusively teaching and promoting curricula, history, science and cultural ideas that are factual, scientifically substantiated with empirical evidence and cannot be classified, whether intentional or not, as religious education or the promotion of a religious ideology and worldview.

Therefore, since the “TAX BILL” has been amended permanently to exclude “School Tax” and “Education Tax”, and we Jason, a man, and Colleen, a woman, have voluntarily paid the other portions of the Tax Bill, we should not have a balance on our “Real Estate Tax Bill”.

HOWEVER, recently, we were sent notice via certified USPS mail that you, Jennifer Cashman, a woman, acting as “Tax Collector” and “Town Clerk” for the TOWN OF BELMONT, will be placing a lien on our property on May 20, 2025 for “unpaid taxes”. We require clarification, since, according to our records, we have been voluntarily paying according to the amended contract titled “TAX BILL” that you have agreed to. **According to our documents and records, WE DO NOT HAVE ANY DELINQUENCIES, and do not agree that you have the right to place a lien on our properties.**

We, Jason and Colleen, intend to continue to honor our agreements with you in “good faith”, Jennifer Cashman, a woman, acting as “Tax Collector”. You have chosen to be uncommunicative and in your lack of communication, you have expressed your approval and agreement with the amended contract. You have also, through your silence, expressed your agreement with the truths written in our May 13, 2024 Affidavit.

Jennifer Cashman, this may be new to you, as very few men and women in Earth have been taught about contract law and the Uniform Commercial Code (UCC): Everything I have stated is the Truth in Law. It is Correct; it is Lawful. If it is “Lawful”, it is in agreement with the Laws of our Creator. Maritime Law and the Uniform

Commercial Code honor this system of contract law, which has its basis in the Holy Bible and which is codified in the Uniform Commercial Code. All contracts must be agreed upon. Ultimately, the Law is designed by God according to what is Right and Just. God is the ultimate designer of freedom as all of mankind is given free will, which even God will not violate. Therefore, violating the free will of another man or woman, as long as their free will does not cause direct harm to another, IS against the Law of God. What is “legal” is not necessarily “lawful”. Legality is what Satan uses to implement the demise of mankind, creating a false justification for wrongful acts of violence against another. Again, the UCC is True and Just and operates according to the laws of all creation, according to the design of the Most High God. The statements that you send out bi-annually, when you are acting as “Tax Collector”, are contract offers which are subject to the “meeting of the minds” otherwise referred to as “negotiation”.

We, mankind, have been kept from knowing how contract law works so that we will “believe” that we can be forced into contracts we do not agree with; so that we “believe” we are victims of “the system” so that we “believe” that we can commit violence against another man or woman if it is “our job” or if it is “legal”. We have been tricked into thinking that is okay to be extorted to pay for something that we know is wrong, like the school system which abuses and indoctrinates children..

You, Jennifer Cashman, a woman, fearfully and wonderfully made by our Creator and Most High God, have a very important choice to make that will have insurmountable spiritual implications for you. You can continue to operate as you have thus far, ignoring our communications and continuing to attempt to extort us Colleen, a woman, and Jason, a man, for money flagged to pay for that which is abhorrent to God and therefore to us. We, Jason and Colleen, have claimed our rights as a man and a woman, as endowed by our Creator. These rights are recognized in our Republic of United States and in the

State of New Hampshire (See the constitutions and bills of rights). These rights include religious freedom and rights to property.

We have shown that we are responsible in that we are *able* to *respond* to contract offers. You, Jennifer Cashman, acting as “Town Clerk” and “Tax Collector” made us an offer, and we attempted to responsibly engage in the “meeting of the minds” of that contract negotiation. We expressed our conditional acceptance of your offer to contract with us if you could prove your claim. You have shown that you are not able to respond to our contract negotiation and through your silence you have chosen to tacitly agree to the amended contract.

Your current insistence on continuing to threaten us and your continuing to falsely and wrongfully claim that we are “delinquent” indicates that, thus far, you are choosing not to govern your life honorably, in accordance with the Laws of God. It indicates that you are actively choosing to engage in behavior akin to organized crime. Through your actions you are creating a world that goes against God and Natural Law. You are personally, as a woman, engaging in violence against a peaceful man and woman. You are single-handedly creating an unjust world; a dishonorable world; a violent world. You willfully design a world that denies the Natural Rights given by the Most High Creator; a world that justifies extortion and abuse of other men and women against their will and without their consent.

What you do next is meaningful for your soul and for your life. It’s your choice. You can do what is Right and Just by honoring the negotiations we made in “good faith”, which you agreed to tacitly, or you can continue to commit violence against us by moving forward with the lien process aimed at seizing our property and home from us.

We require clarification regarding the contract known as “REAL ESTATE TAX BILL”. Why are you choosing not to acknowledge the amended contract which you have agreed to? Why are you claiming we are delinquent when, through your choice not to respond, you have agreed with the amendments we made?

We need to know if you will continue with your unlawful lien process or not. It is up to you.

Notice: You cannot hide from God. You know what is Right and what is Wrong. You are being presented with a choice-point, and what you choose to do matters. Your active will and your active choice matters. You matter. God is merciful and forgiving to those who seek forgiveness and reconciliation, but there is no justification in the spirit for wrong doing. It is our prayer that you will open your heart and choose to honor the laws of God first. Paying for “schools” and “education” is against our sincerely held religious and spiritual beliefs. If you continue with this lien process, your choice will be an affirmation of the upside down world that is being created. It will be a willful act by you, Jennifer, to not honor the laws of God; an affirmation that you, Jennifer, wish darkness to reign in Earth. It’s up to you.

I trust that you do not wish to harass us and harm our family by threatening our property. It is in your power to adjust our “TAX BILL” according to the amendments that you have agreed to. Ignoring our agreements by continuing this lien process would be unlawful.

We, men and women in Earth, have an opportunity to create the world we wish to see. We, Jason and Colleen, wish to create a planet without violence, that honors everyone’s free will, just as God does. We wish to see mankind thrive and live in joy, creativity and abundance. We wish to see the end of trauma-based mind control.

We honor the spark of God which is in every son and daughter of Adam and we invite all of mankind to reconnect with their divine spark and choose to live as if what is Right and Good and Beautiful IS the ONLY way.
