Absent proof of claim, the TOWN OF BELMONT, via tacit agreement, has agreed to the amendments to the contracts known as REAL ESTATE TAX BILL to reflect the removal of "EDUCATION TAX" and "SCHOOL TAX" from our REAL ESTATE TAX BILL, thereby agreeing that Colleen and Jason, and all iterations of our NAME regarding the REAL ESTATE TAX BILL do not have delinquencies etc.

Lex Marcatoria - Law Merchant / Uniform Commercial Code

- Is the TOWN OF BELMONT a corporation?
- Are the women, Jennifer Cashman and Alecia Jipson, acting as AGENTS to the TOWN OF BELMONT?
- Are we, men and women, arbitrating a transaction in commerce according to the practices of the **Uniform Commercial Code** rooted in the ancient law of commerce known as **Law Merchant** (Lex Mercatoria)?
- Have I, Colleen, performed without blemish regarding our contracts called REAL ESTATE TAX BILL?
- Has Jennifer Cashman, agent of the TOWN OF BELMONT failed to perform regarding our contracts called REAL ESTATE TAX BILL?

I have a hunch one of your lawyers knows all of the answers above to be YES, and is keeping you in the dark about it, so you will continue this unlawful process to their benefit and all of our demise, materially for some, spiritually for others.

Accordingly, Jennifer Cashman, Alecia Jipson, the selectmen, and the TOWN OF BELMONT are in violation the Uniform Commercial Code/Law Merchant by making false claims of DELINQUENCY even though, through tacit agreement, Jennifer Cashman, a woman acting as agent called TAX COLLECTOR and the TOWN OF BELMONT have agreed to our amended contracts called REAL ESTATE TAX BILL which we, Jason and Colleen, have upheld with honor. Continuing this fraudulent TAX DEED process based on false claims would constitute a breach of contract.

The New Hampshire Bill of Rights & Laws of God

I contend that if we are to create a peaceful world, according to the laws of God, which are above the laws of man, it is unlawful to force men and women, living souls, to support by force, through the payment of currency known as dollars, that which they know is not true, and that which they know is causing harm to other men, women and children.

Teaching men, women and children curriculum and cultural ideas that are **NOT** able to be verified as true IS akin to teaching religious belief or ideology. Luciferian cult indoctrination, is disseminated covertly. Every individual has a natural and unalienable right to worship God according to the dictates of his own conscience, and reason; and no subject shall be hurt, molested, or restrained, in his person, liberty, or estate, for worshipping God in the manner and season most agreeable to the dictates of his own conscience; or for his religious profession, sentiments, or persuasion; provided he doth not disturb the public peace or disturb others in their religious worship.

June 2, 1784

[Art.] 6. [Morality and Piety.]

As morality and piety, rightly grounded on high principles, will give the best and greatest security to government, and will lay, in the hearts of men, the strongest obligations to due subjection; and as the knowledge of these is most likely to be propagated through a society, therefore, the several parishes, bodies corporate, or religious societies shall at all times have the right of electing their own teachers, and of contracting with them for their support or maintenance, or both. **But no person shall ever be compelled to pay towards the support of the schools of any sect or denomination.** And every person, denomination or sect shall be equally under the protection of the law; and no subordination of any one sect, denomination or persuasion to another shall ever be established.

June 2, 1784

Accordingly, Jennifer Cashman, Alecia Jipson, the selectmen, and the TOWN OF BELMONT are in violation of the New Hampshire Bill of Rights, AND the Natural Laws afforded to all men and women inalienably. In the Laws of God the men and women acting as AGENTS for the TOWN OF BELMONT are willfully trespassing against Colleen and Jason.

PLEASE NOTE:

The below TWO Demands are Time Sensitive and must be provided via certified mail by Tuesday August 25, 2026 to give ample time for review prior to date of the fraudulent "IMPENDING TAX DEED" of 08/31/2026. Absent a timely response, the "IMPENDING TAX DEED" must be delayed.

I demand proof of the Tax Liens listed in the public record that you claim have been registered on the two properties at the address [REDACTED] Belmont, "real estate" listed as [REDACTED] and [REDACTED].

It is evident from our search for such liens that **they do not exist in the public record**. As I had mentioned, in person to Jennifer Cashman, and above, it is my hunch that your Boston Lawyers are not advising you properly and may be keeping you in the dark about what is legal and lawful in regards to our **contracts** titled REAL ESTATE TAX BILL. They may be *leading you to believe* that they have filed a tax lien, when in fact they have not, and cannot. Naturally, I could be wrong, which is why it is necessary that you, Jennifer Cashman, acting as TAX COLLECTOR, and Alecia Jipson, acting as Town Manager, provide the proof of the public registration of claimed tax deeds as is required in New Hampshire Law RSA Chapter 91-A.

I demand proof of the court approval of the Tax Bankruptcy Sale and copies of all documents and correspondence pertaining to said approval, per Section 362 (a) of the Bankruptcy Code.

It is agreed that the cost of performance, such as but not limited to a performance in response to fraudulent letters and notices containing fraudulent or unsubstantiated claims similar to the letters and notices from Jennifer Cashman (JENNIFER CASHMAN) and the Town of Belmont (TOWN OF BELMONT), which are the subject of this letter, is Five Hundred Thousand US dollars, which shall be due from agent, Jennifer Cashman and Five Hundred Thousand US dollars, which shall be due from principal, TOWN OF BELMONT to Colleen Palmer for performance.

The contracts regarding the "real estates" at [REDACTED], often referred to as REAL ESTATE TAX BILL, is between the agents Jennifer Cashman and Colleen and Jason Palmer for the Legal Fictions TOWN OF BELMONT and COLLEEN & JASON PALMER. For any man, woman, legal person, corporation or other entity which would like to join our contracts there will be a Ten Million US dollars joinder fee.

Forcing me, Colleen, to pay in order to halt a tax sale of our properties will constitute "Compelled Performance". I will present a Bill of Lading on the day of performance to both the AGENT, Jennifer Cashman, for Five Hundred Thousand US dollars and the PRINCIPAL, TOWN OF BELMONT for Five Hundred Thousand US dollars. Payment will be due to Colleen Palmer in 30 days.

I, Colleen, a woman and child of God, wish peace and prosperity to all parties involved in our contracts and do extend that forgiveness will always be available to those who ask for it. Forgiveness will be granted when all liens, fees, interest, false claims of delinquency are expunged, compelled payments returned with interest, and the agreed upon amendments to the contracts known as REAL ESTATE TAX BILL are permanently affirmed by principal, TOWN OF BELMONT, and agent, Jennifer Cashman, TAX COLLECTOR.

In closing: According to my comprehension from our interactions...

- You, Jennifer Cashman, Alecia Jipson, and the Select Men have been led to believe, **by your lawyers**, that the TOWN OF BELMONT, and Jennifer Cashman, acting as TAX COLLECTOR, have registered a tax lien on our properties.
- You have been led to believe, **by your lawyers**, that Jennifer Cashman acting as Tax Collector, are obliged only to tell me, Colleen, that "there is no religious exemption for property tax", an exemption that, by the way, that we never asked for.
- You have been led to believe, **by your lawyers**, that you, Jennifer Cashman, and the TOWN OF BELMONT are not **obliged to rebut my Affidavit of Truth** regarding "education" and "school". My Affidavit, in no uncertain terms, proves with exhibited evidence, that "school tax" and "education tax" are being utilized for luciferian cult indoctrination; and are not exclusively utilized for the classic, commonly understood definition of "education" and "school".
- You have been led to believe, **by your lawyers**, that you, Jennifer Cashman, Alecia Jipson, the Select Men, and the TOWN OF BELMONT are not obliged to respond to my **Demand for Proof of your claim** that we must pay for the allocation called "education tax" and "school tax" which are irrefutably NOT "education" or "school", according to the classical definition of the words, but rather appear to be covert Luciferian cult indoctrination intended to harm mankind by abusing and indoctrinating us as children, as was detailed with clear evidence in my Affidavit from May of 2023.
- You all have been led to believe, **by your lawyers**, and perhaps by your worldview, that you, men and women, may continue with the process of issuing a TAX DEED and subsequent tax sale because you believe that you are in the right. You believe that you may ignore my demands without consequence, and that you have done all that is required of you.

If you have been led to believe the list above is correct, I ask you to consider the following:

What if your lawyers, Jennifer and Alecia, are not being honest with you? What if they have you, the tax collector, town manager and select men thinking that you are playing simple checkers, while they are actually playing chess and using you men and women as pawns?

What if someone in the Boston law firm knows all there is to know about Law Merchant, the UCC, knows intimately about the Bills of Exchange, and knows that everything I have brought to the negotiation regarding "REAL ESTATE TAX BILL" is both Legal and Lawful?

What if they know that we, Jason and Colleen, DO NOT HAVE DELINQUENCIES and that you did AGREE with the changes to our contracts known as REAL ESTATE TAX BILL by remaining silent: an agreement they call "tacit agreement"?

What if they are keeping you in the dark about this because they are running a scheme -a fraud-, using the Bills of Exchange, a currency that their class of banksters use for their benefit, and abusing you and the Town staff as their "useful idiots" to enforce this fraud?

It seems to me that there is a spiritual war going on. Mankind is being accused of worshipping Lucifer. Anyone who has been on the planet for 40-50+ years can see the decline of mankind, culture, and quality of life.
